B: Conditions of Participation

1. Introduction

- 1.1 These Conditions of Participation are to be read together with the Schedule to Conditions of Participation. To the extent that there is any inconsistency between the Conditions of Participation and the Schedule to Conditions of Participation, the Schedule to Conditions of Participation prevails. The Conditions of Participation and the Schedule to Condition of Participation shall collectively be referred to as the “Terms and Conditions”. Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Participation. Defined terms will be used singular or plural.
- 1.2 The Organizer reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Redemption Period, make Prize substitutions, cancel, terminate, or suspend the Redemption in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Redemption will constitute their acceptance of the Terms and Conditions (as changed).

3. Eligibility

4.2 In addition, the Organizer reserves the right to disqualify any Participant that:

8. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organizer, its holding, subsidiary or related companies as defined in the Companies Act 2016 (“NESTLÉ Malaysia Group”), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant’s participation in the Redemption, acceptance of any Prize, and/or the use of the Participant’s participation and/or likeness in connection with the Redemption or violation of the Terms and Conditions.
