11. <u>Judging Details – Weekly Consolation Prizes</u>	a. As part of the Weekly Consolation Prizes Finalists’ selection process, the Organiser will allocate serial numbers to the Qualified Entries in accordance with Clause 9, starting from serial number “1”, based on the submission timestamp—from the earliest to the latest Entry. b. Each week, the serial numbers allocated to each Qualified Entry will be tabulated to derive the total number of Qualified Entries for that week (“Total Weekly Qualified Entries”).
